



Easiest Way to think about enrollment for 2019-20

- **CONTINUOUS ENROLLMENT: will occur after Friday, February 1st**
 - **DO NOTHING**
 - All students ENTERING Kindergarten through Grade 8
 - All information from 2018-19 will be rolled into 2019-20. This includes:
 - Personal information
 - Method of Payment
 - Payment Plan
 - Current child(ren), if you are not adding another child
 - All answers to supplement questions
 - All Medical Information remains the same
 - Not applying for financial aid
 - No changes to before school or after school extended day (aftercare)
 - A registration fee of \$150 per family will be automatically billed in March 2019.
- **ONE TIME PAYMENT PLAN**
 - **DEADLINE** – July 25, 2019
 - The 2% discount only applies to paying in full by July of 2019.
- **\$500 Referral Discount**
 - Any family you refer that results in attendance for the 2019-20 school year will result in a \$500 discount on your 2020-21 tuition.

If you need to make any changes: initiate BEFORE Friday, February 1st so your current information will not be automatically rolled over into the 2019-20 school year along with your registration fee.

- **ADMISSIONS**
 - **Start at Admissions Tab if:**
 - You are adding, another family member.
 - You are new and want to enroll.
- **FINANCIAL AID**
 - **Go to Financial Aid Tab if:**
 - You would like assistance with tuition.
 - You can use your 2017 tax return to file, which means you can apply now.
 - **NEW-** Preschool and Prekindergarten students must be enrolled in the **Full Day** program to qualify for financial aid.
 - Our Lady of Peace only awards financial aid to families that have completed all paperwork required by TADS.

- **DEADLINE** March 1, 2019
 - To receive the highest amount of assistance that OLP awards all TADS required paperwork must be completed.
 - After March 1, financial aid will be awarded at a reduced rate
 - **AIM Higher and CSAF Scholarships- DEADLINE** February 17, 2019
 - To qualify for AIM Higher or CSAF Scholarships, be sure to check these boxes at the end of your application in TADS.
- **ENROLLMENT**
 - **Go to the Enrollment Tab if:**
 - You are not enrolling a new student or seeking FINANCIAL AID.
 - You need to make changes to
 - Personal Information
 - Payment Plan
 - Method of Payment
 - Extended Day (Preschool through Grade 8)
 - Supplemental Question
 - Medical Information
 - If you re-enrolling a Preschool or Preschool Plus student
 - Not Attending for the school year 2019-20
 - A \$150 registration fee per family is required to finalize your enrollment
- **AGREEMENT**
 - **Go to Agreement Tab if:**
 - You have completed any or all of the following: admissions, financial aid and/ or enrollment.
 - **DEADLINE** – May 15, 2019
 - May 16-June 30, 2019- late processing fee of \$50.
 - June 30-September 15, 2019- overdue processing fee of \$100.
